

Multi Storey Car Park Adanac Park - Terms and Conditions

The use of the multi-storey car park at Adanac Park for Park & Ride facilities is subject to the agreement of the terms and conditions set out below:

Definitions and clarification of terminology apply in the Terms and Conditions:

- a. Park and Ride means Adanac Park, Park and Ride facilities, Southampton SO16 0AU,
 - b. "The Trust" or "UHS" means University Hospital Southampton NHS Foundation Trust

1. The Park & Ride Parking facilities may only be used while you are attending a Southampton Football club match game. Once you have entered the car park at this point, all terms and conditions are deemed to have been accepted.
 2. The Trust makes every effort to create sufficient car parking capacity for SFC supporters, however, cannot guarantee that a space will be always available.
 3. The car park will be available 3 hours prior to the advertised kick off time and remains open until 2 hours and 15 minutes after the final whistle. You must not have a vehicle parked in the car park outside of these times. If you are unable to move your vehicle within this time period, it will be locked into the car park. You may access your vehicle Monday to Friday between 6:15 and 21:00 excluding Bank Holidays.
 4. If the car is not collected within the timeframe specified, then you are liable to pay £70 as a parking charge notice beyond the hours of the SFC park and ride scheme, reduced to £35 if paid within 14 days.
 5. The Trust reserves the right to refuse admittance to any vehicle that is not using the car park for match day parking.
 6. Your vehicle must be parked in a marked bay and in the designated car park unless you have been directed by traffic marshals to park elsewhere.
 7. In using the car park, you agree not to: a) bring alcohol onto the premises; b) smoke on the premises; c) raise noise levels above what might be reasonably expected in using the car park; and d) use foul or abusive language.
 8. Your Parking privileges may be withdrawn if you are found to have parked in an unauthorised place, such as: a thoroughfare, aisle, on double red lines, over two spaces, in an unallocated car park, in a disabled bay without a valid permit, or are found to have blocked in other vehicles.
 9. The multistorey car park, parking wardens use handheld photographic recording devices to enforce compliance with these terms and conditions
 10. UHS accept no liability, for any loss, damage or theft caused to vehicles (including contents) on the premises. Contents are left at owners risk All vehicles are parked at your own risk. Whilst every effort is made to provide parking services UHS cannot accept liability for delays arising from circumstances from beyond its control including but not limited to traffic congestion, access to the bus service, delayed services, and security alerts.
 11. Acts of nature are beyond our control, and we accept no liability for them including bird droppings, dust, pollen, and rain.
 12. No liability for loss or damage to your vehicle including tyres, windscreens, mechanical and structural failures to interiors will be considered.
 13. All claims for damage should be reported before leaving the car park, whilst your vehicle remains within our care and control. You should make sure you check your vehicle before leaving the car park and report details of any damage to the car park attendant and Southampton Football Club.
 14. If any of these terms are found to be partially or wholly illegal or unreasonable then they shall be deemed severable from the remaining terms, which will continue.
 15. These terms are governed by English laws and subject to English Court jurisdiction.
 16. Your vehicle must be taxed and comply with the Road Traffic Act. You will be held liable for any fines, liabilities, and consequential loss we incur from a failure to do this. We reserve the right to refuse your vehicle on the day if you fail to comply with current legislation.

17. The car park has vehicle height restriction of 2.1m to enter the car park throughout all levels of the building, users are responsible because of not adhering to the height restrictions oversized vehicles cannot use the car park.

18. In the case of an adverse event such as a fire then users should make their way to the designated fire assembly points.

By using the Multi Storey Car Park at Adanac Park I acknowledge and accept that I am bound by these terms and conditions, and I understand that failure to comply with them could lead to withdrawal of parking match privileges.
