

COMPETITION TERMS AND CONDITIONS FOR ENTRY INTO THE SOUTHAMPTON FC BREAK FREE SUMMER FESTIVAL TICKET COMPETITION

1. The prize draw ("**Prize Draw**") is open to all legal residents within the UK aged 18 and over.
2. You will be entered into the Prize Draw if, during the Competition Period, you click and complete the Break Free Summer Festival Ticket Competition.
3. Employees or agencies of the Promoter and its affiliated companies or their family members, or anyone else connected with the Prize Draw will not be eligible for the Prize Draw.
4. Entrants who enter into the Prize Draw shall be deemed to have accepted these Terms and Conditions and the Promoter assumes that all entrants are aged 18 or above and accept these terms and conditions.
